Scope:

To review and grade the applications submitted to the TB REACH Secretariat in response to the first call for proposals.

Objectives:

- 1. Review grant applications and make recommendations to the Stop TB Partnership Coordinating Board on which grant applications to accept and fund and which ones to reject.
- 2. Recommend steps that may be necessary for successful applicants to meet with all conditions for TBREACH support.
- 3. Prepare a PRC report for the STOP TB Partnership Secretariat and the PRC Review Form as feed back to each of the applicants regarding the quality of their proposal (including the clarifications or adjustments that are required, and the reasons for rejecting an application).
- 5. Recommend successful proposals that may require baseline validation via a field visit.
